Summer Youth Volleyball Camp

Program Description:

Learn the game of volleyball in a non-competitive, learning atmosphere. This program introduces youth to volleyball through drills and developmentally appropriate games using special equipment- lowered nets, beach balls for the younger kids, and VolleyLite volleyballs for the older kids, to enhance the learning experience.
