LIABILITY AGREEMENT FOR USE OF THE GRIMES SPORTS COMPLEX

Please return this completed agreement with payment to the Grimes Parks and Recreation Department.

I, the undersigned, understand that the Grimes Sports Complex will be reserved only under the following conditions which I agree to observe. If I do not observe the following conditions, I may incur additional fees.

Please read and initial the following 10 items:

- ___ 1. **No Smoking or tobacco** is allowed on the premises. **No alcohol** is allowed on the premises.
- ___ 2. No commercial fundraising is permitted; however, nonprofit groups are excluded from this restriction.
- ___ 3. The Grimes Sports Complex must be vacated by 10pm by all parties unless otherwise approved.
- ___ 4. The reserving individual is responsible for normal cleanup procedures: trash bagged, dugouts (if used) swept, bleachers cleared off of garbage, equipment (if used) returned, and the fields raked for the next rental. If you notice the fields are left in poor condition when you get there, please call 986-2143 or 205-8881 to report the poor conditions before you start.
- ___ 5. City staff will not be called out for non-emergency related items, \$60 to \$80 may be charged based on the non-emergency related call-outs.
- ___ 6. The undersigned agrees to pay for any damage to the Grimes Sports Complex buildings and/or property (fields) and also agrees to pay replacement costs for any missing items. In addition, the undersigned individual agrees to pay a \$40/hr. cleanup cost if the Grimes Sports Complex and/or property is left in unsatisfactory condition and their deposit will be kept.
- ___ 7. Individuals causing harm to the Grimes Sports Complex property will be denied use of the complex in the future.
- ___ 8. If city personnel are dispatched you will incur up to \$80 in fees to offset that cost.
- ___ 9. The light key (for lit soccer field) must be picked up during normal business hours (9AM-5PM) at the Grimes Parks and Rec Office. If you fail to pick up a key, you will be charged \$60- \$80 to compensate for the call-out pay to have city personnel unlock the lights for you. The key must be returned by the next business day. There are charges to use the lights.
- ___ 10. The undersigned understands and hereby acknowledges that the City of Grimes shall not be responsible or liable for personal injury or property damage occurring to persons or their guests and invitees, while using the Grimes Sports Complex for their own personal matters, or for matters unrelated to the business of the City of Grimes.

NOTE: Understand if the local sports clubs need the fields due to earlier rain-outs (per Field Use Policy), they will give us a 24-hr notification and a refund of the deposit and the fees will occur for your paid rental.

The undersigned releases and discharges the City of Grimes from any liability, claims, demands, injuries, damages, actions or causes of action that might occur arising from the use of the City of Grimes premises.
