Explanation of significant increases in the budget:

Property valuations increased due to growth in the City and revaluations. The proposed budget increases property tax revenue by 4.79 percent. The total city tax rate proposed for FY23 will be decreasing from the current year (\$11.41284) to \$11.18908.
