NOTE - READ CAREFULLY

- A permit is required before any work begins.
- A permit will expire if work is not started within 90 days of the permit date, or if work is abandoned for 180 days.
- Except as provided by law, where work has been started prior to obtaining a permit, the regular fee therefore may be doubled at the discretion of the Building Official.
- It is the responsibility of the permittee to call for all inspections.
- ALL WORK MUST BE INSPECTED.
- The applicant is assumed to be knowledgeable of the Code.
- Permits are non-transferable, all work shall be performed by permittee or his/her employee.
- Stamped signatures will not be accepted.
- Questions should be resolved prior to installation.
- Permits shall not be issued until fees have been paid.
- No work shall be concealed or covered until approved by the inspector.
