**9.01 PURPOSE.** The purpose of this chapter is to provide for a partial exemption from property taxation of the actual value added to industrial real estate by the new construction of industrial real estate, research-service facilities, warehouse, distribution centers and the acquisition of or improvement to machinery and equipment assessed as real estate.

**9.02 DEFINITIONS.** For use in this chapter the following terms are defined:

1. "Actual value added" means the actual value added as of the first year for which the exemption is received, except that actual value added by improvements to machinery and equipment means the actual value as determined by the local assessor as of January 1 of each year for which the exemption is received.
2. "Distribution center" means a building or structure used primarily for the storage of goods which are intended for subsequent shipment to retail outlets. Distribution center does not mean a building or structure used primarily to store raw agricultural products, used primarily by a manufacturer to store goods to be used in the manufacturing process, used primarily for the storage of petroleum products, or used for the retail sale of goods.
3. "New construction" means new buildings and structures and includes new buildings and structures which are constructed as additions to existing buildings and structures. New construction does not include reconstruction of an existing building or structure which does not constitute complete replacement of an existing building or structure or refitting of an existing building or structure unless the reconstruction of an existing building or structure is required due to economic obsolescence and the reconstruction is necessary to implement recognized industry standards for the manufacturing and processing of specific products and the reconstruction is required for the owner of the building or structure to continue competitively to manufacture or process those products, which determination shall receive prior approval from the City Council of the City

upon the recommendation of the Iowa Department of Economic Development.

4. "New machinery and equipment assessed as real estate" means new machinery and equipment assessed as real estate pursuant to Section 427A.1, Subsection 1, Paragraph "e", Code of Iowa, unless the machinery or equipment is part of the normal replacement or operating process to maintain or expand the existing operational status.

5. "Research-service facilities" means a building or group of buildings devoted primarily to research and development activities, including, but not limited to, the design and productions or manufacture of prototype products for experimental use, and corporate research services which do not have a primary purpose of providing on-site services to the public.

6. "Warehouse" means a building or structure used as a public warehouse for the storage of goods pursuant to Chapter 554, Article 7, of the Code of Iowa, except that it does not mean a building or structure used primarily to store raw agricultural products of from which goods are sold at retail.

9.03 PERIOD FOR PARTIAL EXEMPTION. The actual value added to industrial real estate by the new construction of industrial real estate, research-service facilities, warehouse, distribution centers, and the acquisition of or improvement to machinery and equipment assessed as real estate, is eligible to receive a partial exemption from taxation for a period of five (5) years.

9.04 AMOUNTS ELIGIBLE FOR EXEMPTION. The amount of actual value added which is eligible to be exempt from taxation shall be as follows:

1. For the first year, seventy-five percent (75%)
2. For the second year, sixty percent (60%)
3. For the third year, forty-five percent (45%)
4. For the fourth year, thirty percent (30%)
5. For the fifth year, fifteen percent (15%)

9.05 LIMITATIONS. The granting of the exemption under this chapter for new construction constituting complete replacement of an existing building or structure shall not result in the assessed value of the industrial real estate being reduced below the assessed value of the industrial real estate before the start of the new construction added. The exemption under this chapter shall not apply to any business regulated in Chapter 126 or 127.

9.06 APPLICATIONS. An application shall be filed for each project resulting in actual value added for which an exemption is claimed.

1. The application for exemption shall be filed by the owner of the property with the local assessor by February 1 of the assessment year in which the value added is first assessed for taxation.
2. Applications for exemption shall be made on forms prescribed by the Director of Revenue and shall contain information pertaining to the nature of the improvement, its cost, and other information deemed necessary by the Director of Revenue.

9.07 APPROVAL. A person may submit a proposal to the City Council to receive prior approval for eligibility for a tax exemption on new construction. If the City Council resolves to consider such proposal, it shall publish notice and hold a public hearing thereon. Thereafter, at least thirty days after such hearing, the City Council, by ordinance, may give its prior approval of a tax exemption for new construction if the new construction is in conformance with City zoning. Such prior approval shall not entitle the owner to exemption from taxation until the new construction has been completed and found to be qualified real estate.

9.08 EXEMPTION REPEALED. When in the opinion of the City Council continuation of the exemption granted by this chapter ceases to be of benefit to the City, the City Council may repeal this chapter, but all existing exemptions shall continue until their expiration.

9.09 DUAL EXEMPTIONS PROHIBITED. A property tax exemption under this chapter shall not be granted if the property for which the exemption is claimed has received any other property tax exemption authorized by law.

#### EDITOR'S NOTE

Ordinance No. 360, granting prior approval of tax exemption for new construction to Gateway Partners, was adopted by the Council on April 12,

1994, and is not included in the Code of Ordinances, but is specifically saved from repeal and in full force and effect.

Ordinance No. 365, granting prior approval of tax exemption for new construction to Hawkeye Commodities Company and Bruno & Marilyn Andreini, was adopted by the Council on December 13, 1994, and is not included in the Code of Ordinances, but is specifically saved from repeal and in full force and effect.

Ordinance No. 368, granting prior approval of tax exemption for new construction to Sprayer Specialties, was adopted by the Council on February 28, 1995, and is not included in the Code of Ordinances, but is specifically saved from repeal and in full force and effect.

Ordinance No. 376, granting prior approval of tax exemption for new construction to John Chavas, Inc. d/b/a Chavas Vending, was adopted on October 10, 1995, and is not included in the Code of Ordinances, but is specifically saved from repeal and in full force and effect.

Ordinance No. 377, granting prior approval of tax exemption for new construction to Gateway Partners was adopted on October 15, 1995, and is not included in the Code of Ordinances, but is specifically saved from repeal and in full force and effect.

Ordinance No. 388, granting prior approval of tax exemption for new construction to John and Janet Carroll was adopted on December 12, 1995, and is not included in the Code of Ordinances, but is specifically saved from repeal and in full force and effect.

Ordinance No.417, granting approval of tax exemption for new construction to SLK Development was adopted by the Council on October 13, 1998 and is not included in the Code of Ordinances, but is specifically saved from repeal and in full force and effect.

Ordinance No. 428, granting approval of tax exemption for new construction to Exterior Sheet Metal, Inc. was adopted by the Council on August 10, 1999, and is not included in the Code of Ordinances, but is specifically saved from repeal and in full force and effect.

Ordinance No. 429, grantine approval of tax exemption for new construction to Robison Properties, LTD. was adopted by the Council on August 24, 1999, and is not included in the Code of Ordinances, but is specifically saved from repeal and in full force and effect.

Ordinance No. 433, granting approval of tax exemption for new construction to ASSK Properties, Inc., was adopted by the Council on March 28, 2000, and is not included in the Code of Ordinances, but is specifically saved from repeal and in full force and effect.
